DIRECTIONS

From the West of Toronto

Take Hwy 401 to Hwy 410 North (exit 344). Follow 410 North to Derry Rd exit. Exit right onto Derry Rd. Follow to Airport Road and make a slight right. 6900 Airport Road is on the right

From the East of Toronto

Take Hwy 401 to Hwy 409, exit right at Hwy 409. Follow Hwy 409 to the Hwy 427/Viscount Rd/Hwy7/Airport Rd exit. At the exit, take the Hwy-427 South exit on the left toward Hwy 401 W Follow the ramp carefully to Airport Road, making a right onto Airport Rd N. You will then make a U-turn onto Airport Rd S, and 6900 Airport Rd is on the right
